

## Notice to Employee

Do you have to file? Refer to the Form 1040 instructions to determine if you are required to file a tax return. Even if you do not have to file a tax return, you may be eligible for a refund if box 2 shows an amount or if you are eligible for any credit.

**Earned income credit (EIC).** You may be able to take the EIC for 2014 if your adjusted gross income (AGI) is less than a certain amount. The amount of the credit is based on income and family size. Workers without children could qualify for a smaller credit. You and any qualifying children must have valid social security numbers (SSNs). You cannot take the EIC if your investment income is more than the specified amount for 2014 or if income is earned for services provided while you are in prison or a penal institution. For 2014 income limits and more information, visit [www.irs.gov/efile](http://www.irs.gov/efile). Also see Pub. 596, Earned Income Credit. Any EIC that is more than your tax liability is refunded to you, but only if you file a tax return.

**Clergy and religious workers.** If you are not subject to social security and Medicare taxes, see Pub. 517, Social Security and Other Information for Members of the Clergy and Religious Workers.

**Conventions.** If you name, SSN, or address is incorrect, correct copies (i, c, and 2) and ask your employer to correct your employment record. Be sure to ask the employer to file Form W-2, Corrected Wage and Tax Statement, with the Social Security Administration (SSA) to correct any name, SSN, or money amount error reported to the SSA on Form W-2. Be sure to get your copies of Form W-2 from your employer for all corrections made so you may file them with your tax return. If your name and SSN are correct but are not the same as shown on your social security card, you should ask for a new card that displays your correct name at any SSA office or by calling 1-800-772-1213. You also may visit the SSA at [www.socialsecurity.gov](http://www.socialsecurity.gov).

**Cost of employer-sponsored health coverage.** If such cost is provided by the employer, the reporting in box 12, using code DD, of the cost of employer-sponsored health coverage is for your information only. The amount reported with code DD is not taxable.

**Credit for excess taxes.** If you had more than one employer in 2014 and more than \$7,200 in social security and/or Tier 1 railroad retirement (RRTA) taxes were withheld, you may be able to claim a credit for the excess against your federal income tax. If you had more than one employer and more than \$1,650 in Tier 2 RRTA tax was withheld, you also may be able to claim a credit. See your Form 1040 or Form 1040A instructions and Pub. 505, Tax Withholding and Estimated Tax.

### Instructions for Employee

**Box 1.** Enter this amount on the wages line of your tax return.

**Box 2.** Enter this amount on the federal income tax withheld line of your tax return.

**Box 3.** You may be required to report this amount on Form 9255, Additional Medicare Tax. See Form 1040 instructions to determine if you are required to complete Form 9255.

**Box 4.** The amount includes the 1.45% Medicare Tax withheld on all Medicare wages and tips shown in Box 5, as well as the 0.9% Additional Medicare Tax on any of those Medicare wages and tips above \$200,000.

**Box 5.** This amount is not included in boxes 1, 3, 5, or 7. For information on how to report tips on your tax return, see your Form 1040 instructions.

You must file Form 4137, Social Security and Medicare Tax on Unreported Tip Income, with your income tax return to report or elect the allocated tip amount unless you can prove that you received a smaller amount. If you have records that show the actual amount of tips you received, report that amount even if it is more or less than the allocated tip. On Form 4137 you will calculate the social security and Medicare tax owed on the allocated tips shown on your Form(s) W-2 that you must report as income and as other tips you did not report to your employer. To file Form 4137, your social security tips will be credited to your social security record based on figure your benefits.

**Box 6.** This amount includes the total dependent care benefits that your employer paid to you or incurred on your behalf (including amounts from a section 125 (cafeteria) plan). Any amount over \$5,000 is also included in box 1. Complete Form 2441, Child and Dependent Care Expenses, to complete any taxable and nontaxable amounts.

**Box 7.** This amount is (a) reported in box 1 if it is a distribution made to you from a nonqualified deferred compensation or nonqualified section 457(b) plan or (b) included in box 2 and/or 3 if it is a prior year deferred under a nonqualified or section 457(b) plan that became taxable for social security and Medicare taxes this year because there is no longer a substantial risk of forfeiture at your age to the deferred amount. This box should not be used if you had a deferral and a distribution in the same calendar year, and you are or will be age 62 by the end of the calendar year; your employer should file Form SSA-121, Employer Report of Special Wage Payments, with the Social Security Administration and give you a copy.

**Box 8.** The following list explains the codes shown in box 12. You may need this information to complete your tax return. Elective deferrals (codes D, E, F, and G) and designated Roth contributions (codes AA, BB, and DD) under all plans are generally limited to a total of \$17,500 (\$12,000 if you only have SIMPLE plans, \$20,500 for section 408(b) plans if you qualify for the 15-year rule explained in Pub. 571). Deferrals under code G are limited to \$17,500. Deferrals under code H if you are in 2014, your employer may have allowed an additional deferral of up to \$5,500 (\$2,500 for section 401(k)(11) and 408(k) SIMPLE plans). This additional deferral amount is not subject to the overall limit on elective deferrals. For code G, the limit on elective deferrals may be higher for the last 3 years before you reach retirement age. Contact your plan administrator for more information. Amounts in excess of the overall elective deferral limit must be included in income. See the "Wages, Salaries, Tips, etc." tax instructions for Form 1040.

**Code A:** If a year follows code G through H, S, V, AA, BB, or EE, you made a rollover pension contribution for a prior year(s) when you were in military service. It figures whether you made excess deferrals, or under these amounts for the year shown, not the current year. If no year is shown, the contributions are for the current year.

**A—Uncollected social security or RRTA tax on tips.** Includes this tax on Form 1040. See "Other Taxes" in the Form 1040 instructions.

**B—Uncollected Medicare tax on tips.** Includes this tax on Form 1040. See "Other Taxes" in the Form 1040 instructions.

**C—Taxable cost of group-term life insurance over \$50,000 (included in boxes 1, 3 (up to social security wage base), and 5).**

**D—Elective deferrals to a section 401(k) cash or deferred arrangement.** Also includes deferrals under a SIMPLE retirement account that is part of a section 401(k) arrangement.

**E—Elective deferrals under a section 408(k) salary reduction agreement.**

**F—Elective deferrals under a section 408(k)(6) salary reduction SEP.**

**G—Elective deferrals and employer contributions (including nonexcess deferrals) to a section 457(b) deferred compensation plan.**

**H—Elective deferrals to a section 501(c)(12)(D) tax-exempt organization plan.** See "Deferred Gross Income" in the Form 1040 instructions for how to deduct.

**J—Nontaxable sick pay (information only, not included in boxes 1, 3, or 5).**

**K—20% excise tax on excess golden parachute payments.** See "Other Taxes" in the Form 1040 instructions.

**L—Substantiated employee business expense reimbursements (information only).**

**M—Uncollected social security or RRTA tax on taxable cost of group-term life insurance over \$50,000 (former employees only).** See "Other Taxes" in the Form 1040 instructions.

**N—Uncollected Medicare tax on taxable cost of group-term life insurance over \$50,000 (former employees only).** See "Other Taxes" in the Form 1040 instructions.

**P—Excludable moving expense reimbursements paid directly to employee (not included in boxes 1, 3, or 5).**

**Q—Nontaxable combat pay.** See the instructions for Form 1040 or Form 1040A for details on reporting this amount.

**R—Employer contributions to your Annuity MSA, Report on Form 8853, Archer MSAs and Long-Term Care Insurance Contracts.**

**S—Employee salary reduction contributions under a section 105(b) SIMPLE plan (not included in box 1).**

**T—Adoption benefits (not included in box 1).** Complete Form 8839, Qualified Adoption Expenses, to complete any taxable and nontaxable amounts.

**V—Income from exercise of nonstatutory stock option(s) (included in boxes 1, 3 (up to social security wage base), and 5).** See Pub. 525 and instructions for Schedule D (Form 1040) for reporting requirements.

**W—Employer contributions (including amounts the employee elected to contribute using a section 125 (cafeteria) plan) to your health savings account.** Report on Form 8879, Health Savings Accounts (HSAs).

**Y—Deferrals under a section 408(a) nonqualified deferred compensation plan.**

**Z—Income under a nonqualified deferred compensation plan that fails to satisfy section 408(a).** This amount is also included in box 1. It is subject to an additional 20% tax plus interest. See "Other Taxes" in the Form 1040 instructions.

**AA—Designated Roth contributions under a section 401(k) plan.**

**BB—Designated Roth contributions under a section 408(k) plan.**

**DD—Cost of employer-sponsored health coverage.** The amount reported with Code DD is not taxable.

**EE—Designated Roth contributions under a governmental section 457(b) plan.** This amount does not apply to contributions under a tax-exempt organization section 457(b) plan.

**Box 12.** If the "Roth election plan" box is checked, special limits may apply to the amount of traditional IRA contributions you may deduct. See Pub. 590, Individual Retirement Arrangements (IRAs).

**Box 14.** Employers may use this box to report information such as state disability insurance taxes withheld, union dues, uniform payments, health insurance premiums deducted, nontaxable income, educational assistance payments, or a member of the employer's pension allowance and offset. Full-time employees use this box to report unpaid rollover(s) (RRTA) contributions, Tier 1 tax, Tier 2 tax, Medicare tax and Additional Medicare Tax, include tips reported by the employee to the employer in railroad retirement (RRTA) compensation.

**Note.** Keep Copy C of Form W-2 for at least 3 years after the due date for filing your income tax return. However, to help protect your social security benefits, keep Copy C until you begin receiving social security benefits, and in case there is a question about your work record and/or earnings in a particular year.
