Subject: Cyber-bullying	Internet Topic: Cyber-bullying (Definition)	
Grade Level: 9

Resources: Cyber Bullying Definition article, paper, pens/pencils, highlighters.		

Teaching Objectives:

The student will define "cyber bullying" and gain greater knowledge of the risks involved in internet chatting. The student will define specific vocabulary from the article, including bully, cyber bully, chat rooms, chatting, screen name, exploitation, anonymity, prey, acquaintance, affinity, menacing, transcripts, warrants, savvy.

	Planned Content/ Lesson Outline		
1.	Begin casual conversation with students, discussing the Internet, chat		
	rooms, etc. Ask students questions regarding their awareness of Internet		
	dangers. Discuss bullying. Ask students if they are familiar with "cyber"		
	bullying.		
2.	Distribute Cyber Bullying Definition article. Have students read		
	individually, or read aloud. While reading the article, instruct students to		
	highlight (or write on their own paper) any terms they are unfamiliar with.		
3.	Write terms on the board and review/define with students.		
4.	Discuss the article, emphasizing dangers/risks of chat room activity. Ask students to relate, if possible.		
5.	Instruct students to write a short paper (length to be determined by teacher)		
	discussing what they now know about Internet safety and cyber bullying,		
	referencing any personal experiences or those of friends. Also, instruct		
	students to discuss the intrigue of certain websites.
