**PURPOSE:** The Lampo Group, Inc. (Lampo) offers continuing education units (CEUs) for its Financial Peace programs, seminars and workshops as an Authorized Provider of the International Association for Continuing Education and Training (IACET).

**REQUIREMENTS:** In order to be awarded CEUs for FPU, you must attend at least 11 of the 13 FPU sessions; be present the entire session when you attend; participate during the sessions you attend; and do all assigned out-of-class reading and exercises.

**CEUS AVAILABLE:** One-tenth of one CEU will be awarded for each hour of involvement in the program, based on an estimate of two hours in class and one hour of out-of-class work for each session. For attending 11 sessions you will earn 3.3 CEUs; for attending 12 sessions you will earn 3.6 CEUs; for attending 13 sessions you will earn 4.0 CEUs.

**PARTICIPATION:** To be eligible to receive continuing education units you must participate in discussions and exercises, and complete all workbook entries and reading assignments. If you miss a session you may attend the same session at another location, if one is available. Your coordinator will assist you in locating a convenient nearby FPU program for that purpose.

**REQUIRED FORMS:** This application is the only form you will need. Fill it out and give it to your *Financial Peace University* coordinator at the first session that you attend. Your coordinator should be able to provide you with this form or give you one to copy. If not, you or your coordinator may download one at daveramsey.com or order copies by phone from the Lampo CE/T Group at the telephone number shown below.

**INSTRUCTIONAL METHODS:** *Financial Peace University* is taught by Dave Ramsey on DVD and CD and facilitated by your coordinator. You will view the lesson DVDs, complete exercises relating to personal finance and budgeting in a workbook, read portions of Dave Ramsey's books, and participate in exercises and discussions in class.

**AWARDING OF CEUS:** At the conclusion of the *Financial Peace University* program, your coordinator will sign this application, note the number of CEUs you have earned, and make two copies—one for you, and one for Lampo. A certificate awarding you the appropriate number of continuing education units will be given to you. The original of this application will be sent to Lampo's Continuing Education/Training Group for use in establishing your permanent record. If you are not entitled to receive any CEUs, you will be told why and you will be given specific suggestions for correcting that situation.

**RIGHT TO PRIVACY:** You have a right to privacy with regard to your progress in meeting the CEU requirements. Your coordinator will not reveal to any third party any information regarding your CEU application or its resolution. Your record at Lampo will be secured and will be accessible only to the administrative staff of Lampo's Continuing Education/Training Group.

**RECORD RETENTION AND RELEASE:** A separate permanent record (your name, address, telephone, password, the beginning and ending dates of your FPU program, the name and contact information of your coordinator, and the number of CEUs you earned) will be generated upon receipt by Lampo of this fully executed application. It will be retained seven calendar years, not including the year in which the CEUs were earned. Upon receipt of a signed request containing your name, address and selected password, as well as the program dates and your coordinator's name, Lampo will, within 30 days, furnish to you or your designee a copy of your record, signed or attested to by an authorized CE/T Group staff member.

**YOUR PASSWORD:** You must select and enter on this form a password, which may consist of as few as six and as many as 12 letters and numbers. Once you have been awarded CEUs and a permanent record has been established, this password must be used by you or your designee when requesting access to that permanent record from the Lampo CE/T Group staff.
